C.K. McClatchy High School has the largest student enrollment in the SCUSD, and is growing. It offers the largest number of competitive athletic teams and has more student athletes than any other high school in the district.

The campus also has the smallest footprint among district high schools with athletic facilities that are grossly outdated and in many cases unsafe to both athletes and spectators.
